In consideration of acceptance into Roy Hobbs Baseball (hereinafter "RH Baseball") and its national affiliate Roy Hobbs Diamond Enterprises Ltd., L.L.C., d.b.a. Roy Hobbs Baseball (hereinafter "RHDE") and the payment of the required team/player fees (set by and paid to RHDE):

- I voluntarily agree to play for the team listed above pursuant to the terms and conditions contained in this contract.
- I agree to conduct myself in a manner that will reflect favorably upon my teammates, fellow competitors, spectators, the league and the game.
- I agree to abide by and comply with the rules and regulations adopted by RHDE and used at RHWS.
- I understand that the violation of this contract, the rules and regulations adopted by RHDE Baseball or the violation of certain of the rules of baseball may result in penalties, suspension or expulsion without reimbursement of any fees that may have been paid.
- I understand that certain risks of injury are inherent in my participating in the game of baseball, and, having full knowledge of such risk, I voluntarily assume them of my own accord.
- I agree to hold - my team and its sponsors; RHWS and its officials, sponsors and field owners; RHDE and its officials; and all participating communities and their representatives - harmless of any responsibility, financial or otherwise, due to any injuries received while playing, practicing or traveling to and from events or while participating in any league or association activity.
- I, for myself, my heirs, executors and administrators, hereby voluntarily release, forever discharge and agree to indemnify and hold harmless the above team and organizations (RHWS, RHDE and their officials) from any and all claims, demands or causes of action which are in any way connected with my participation in any RHDE/RHWS activity or my use of RHDE equipment or facilities including such claims which allege negligent acts or omissions of RHDE.
- Should RHWS and its officials, RHDE and its officials or anyone on their behalf be required to incur attorneys fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs.
