Tom meets all the qualifications that we require. Granted, Roy Hobbs was not mentioned only 4 times in all the responses and the nomination form. He has accomplished quite a bit for the DCMSBL, and if I were looking for a financial attorney, he would be my top choice.

Tom has played in the Roy Hobbs World Series since 1998, but he plays locally in the DC MSBL league, and its president, Larry Lombardi, a close associate for many years, agreed to handle the nomination. (Talked to TG about this, and he said he wasn't concerned with the pedigree of the nomination but rather his knowledge of the subject.)

The one tricky thing about this process, having been on both sides of it, is presenting socalled concrete examples of Character and Stand-out. This is a very subjective aspect, and people seem to struggle with it the most.

1. Please tell us how this individual and his character affect Roy Hobbs Baseball, the game of baseball and his baseball colleagues on and off the field, and why.

Tom has been with the DCMSBL since 1998 starting out as a player and subsequently becoming a team manager in our 40+ and 60+ age groups and currently playing as a player in our 70+ age group.

Tom's background as a former law professor, specifically his leadership role in mentoring students and young professionals, were carried over into how Tom managed his teams in our younger age group adult baseball teams in the DCMSBL. One of the aspects in which Tom has been excellent in mentoring many players on his teams over the years, who for the most part were much younger, was about respecting the game of baseball. There was never a player issue with any of the players who were on Tom's teams over the years. Tom's principled leadership approach as a team manager prioritized integrity and individual responsibility.

Tom always exhibited a collaborative and a competitive spirit when it came to the game of baseball. There was a period of a few years when Tom was coaching his 40+ team where his team was, let's say not as competitive as the rest of the 40+ age group, he approached the league about a possible solution. Tom's solution would keep his team competitive in the 40+ age group and at the same time maintain the consistency of play for all the other 40+ teams. Because of Tom's vast experiences in the financial and legal world, he was able to bridge the gap and leverage a forward-thinking approach to the situation above which demonstrated a pro-active, transparent and effective solution not only for his team but for the integrity of the age group.

Regarding Tom's character off the field, he has made some impactful contributions over the years to the community through his music and baseball. The Washington All Stars team, which was established in 1998, is dedicated to raising money for Special Olympics and every year they end up their season playing in the Roy Hobbs World Series. With the encouragement of Tom's close friend and mentor, R. Sargent Shriver, suggested that Special Olympics could benefit from the Washington All Star team's love of baseball. Through 2024, the Washington All Star team has raised more than \$550,000 for Special Olympics.
